

**MINUTES – INLAND VALLEY BRIDGE UNIT 534**

*News from ACBL* – ACBL reported that the table fees would increase by 25% and membership fees would increase by 20% effective January 1, 2024.

The senior center did confirm that the bridge club would have access to both rooms, meaning the room we had been using and the small room adjacent to that room, which will allow more space. A motion was made, seconded and carried to thank Kathy for her time and presented her with a “thank you gift” of \$75.00.

*Extra Tables, Bidding Boxes, Boards and Card Tables* - The unit has these extra supplies that need to be disposed of once Temecula opens. The Board agreed to offer these supplies first choice to the new players and then to other members. A donation will be requested from those that show interest in the items.

*Fellowship Luncheon* – Judy will be sponsoring a catered luncheon on 11/18, which will replace the Christmas luncheon. Due to the rising cost of food, Judy has requested a donation of \$300.00 from the unit for this event. Motion made, seconded and carried to donate \$300.00 toward the fall luncheon.
